The initial meeting of the Michigan Wildlife Council, a nine-member public body created by Public Act 246 of 2013 to develop and implement, in conjunction with a third-party marketing or advertising agency, a comprehensive media-based public information program to promote the essential role sportsmen and sportswomen play in furthering wildlife conservation and to inform the general public about hunting, fishing and the taking of game, began at 1:00 p.m. Wednesday, August 6, 2014, in the Learning Center located on the first floor of the Michigan Historical Center, 702 W. Kalamazoo Street, Lansing.

# **Introductions**

Department of Natural Resources Director **Keith Creagh** introduced **Brian Breslin**, manager of appointments for Governor **Rick Snyder**, and Michigan Representative **Jon Bumstead**, chairman of the House Committee on Appropriations for Natural Resources.

**Creagh** also introduced **Jim Dexter**, chief of the DNR Fisheries Division; **Ron Olson**, chief of the DNR Parks and Recreation Division; and **Kelly Siciliano Carter**, public outreach; engagement manger in the DNR Wildlife Division; and **Kristin Phillips**, chief of DNR Marketing and Outreach Division, as well as representatives from the Michigan United Conservation Clubs (MUCC), Ducks Unlimited and Michigan State University.

Creagh then turned the meeting over to Jordan Burroughs from Michigan State University Extension and the DNR who conducted an "icebreaker" exercise to aid in the introduction of the nine, newly appointed council members: Merisa Campbell of Johannesburg; Keith Creagh of Lansing; James H. Hammill of Crystal Falls; Carol Moncrieff Rose of Hillman; Matthew R. Pedigo of Howell; Jeffery Poet of Clare; Alan N. Taylor of Rockford; Henry Stancato of Detroit; and Randy Stec of Caro.

## **Overview and Expectations**

Director **Creagh** gave an overview of the statutory duties and obligations of the council and asked each council member what his/her expectations were for the group. **Creagh** spoke about the business of the council and suggested members begin thinking about a timeframe.

#### **Colorado Presentation**

**Tom Burke**, current chair of the Colorado Wildlife Council; **Bob Radocy**, creator of the original "Colorado Model" of public education; and **Tom Leydon**, CEO at PILGRIM Advertising and Digital Marketing Agency, gave a perspective of the Colorado Wildlife Management Public Education Plan devised in 1998. The presenters explained that the purpose of the plan was to design a comprehensive media-based public information program to educate the general public about the benefits of wildlife, wildlife management and, ultimately, the positive role sportsmen play in the funding of professional management and protection of wildlife and its habitat. They talked about the Colorado Plan's goals and objectives and funding for programs that were developed to inform the non-hunting, non-fishing public about the value of hunting and fishing. Suggestions were made for the focus of the Michigan Wildlife Council.

The meeting was recessed at 5 p.m. to be reconvened at 8:00 a.m. Thursday, August 7.

**Creagh** opened the meeting with a brief recap of the prior day's events then introduced Natural Resources Deputy **Bill Moritz** who gave a presentation on keeping natural resources relevant.

**Moritz** talked about communicating to the people of Michigan the relevancy of angling, hunting, recreation, forestry and timber, and mining activities and how natural resources relate to the economy, jobs, and quality of life. **Moritz** also discussed the positive role anglers and hunters play in society, how conservation is funded, the challenges of retaining youth, and the goals of the DNR.

**Creagh** distributed an article written by William A. Demmer, president of the Boone and Crockett Club, entitled *The Economics of Hunter-Conservation*.

## **Introduction of Guest**

Councilmember **Alan Taylor** introduced his guest, Steven Vander Ark, attorney and board member of the Nimrod Society.

#### Adoption of Bylaws

A discussion was held on the proposed bylaws, with members agreeing that the council shall be known as the Michigan Wildlife Council, and its fiscal year shall run from October 1 to September 30 of each year. Discussion was also held on the roles of, and relationship between, the council and the DNR.

The draft of the proposed bylaws presented by council member **Keith Creagh** did not include the offices of secretary or treasurer. Council member **Alan Taylor** suggested both offices would be beneficial to the council. Following further discussion, the council added the office of treasurer.

After a lengthy discussion and editing of the draft, council member **Carol Rose** made a motion that the proposed bylaws, as edited, be adopted subject to the review and concurrence of the Attorney General's office. **Alan Taylor** supported the motion. A vote was taken, and the motion passed unanimously. A copy of the approved bylaws is attached hereto.

## **Election of Officers**

Council members decided that officers of the council shall be chairperson, vice chairperson and treasurer.

**Jeff Poet** made a motion that **Carol Rose** be elected chairperson. **Alan Taylor** supported the motion, and it passed unanimously.

**Merisa Campbell** made a motion that **Matt Pedigo** be elected vice chairperson. **Randy Stec** supported the motion, and it passed unanimously.
